2020 Workgroup Accomplishments

Referrals Workgroup

- Updated and promoted the e-Directory of Home Visiting Programs on the Consortium website. To date, over **2400** forms have been filled out since the launch in April 2019.
- Resources for Parents page created for Consortium website based on the Barriers into Ancillary Services survey.
- Collaborated with the Advocacy Workgroup, Tenants Together and the Eviction Defense Network to host a housing webinar series focused on tenant rights.
- Re-conducted the Ancillary Service Referral Barriers Survey for 2020.
- Created and distributed COVID-19 Virtual Needs Survey for Families in English and Spanish.
- Began revisions to a follow-up survey for families about their virtual home visiting needs and experiences.

Best Practices Workgroup

- Revised and administered 2020 Annual Training Survey and planned timeline for 2021 distribution.
- Revised Program Self-Assessment Survey to administer in early 2021
- Created training directory tool to promote best practices training directory.
- Collaborated with Peace Over Violence to offer Domestic Violence trainings to home visitors in LA County.
- Continuously updated the Training Directory

Data Workgroup

- Completed pilot descriptive data collection of FY 18-19 data with 5 out of 7 major home visiting models in LA County, and launched full-scale descriptive data collection.
- Updated the Home Visiting Needs/Capacity graphic with recent expansion data
- Created and administered COVID-19 Virtual Home Visiting surveys for managers and frontline staff
- Created and published two new infographics and two new reports based on COVID-19 Virtual Home Visiting survey results
- Finalized and published comparable benchmark data for FY 18/19

Advocacy Workgroup

- Endorsed letters in support of California Department of Social Services: CalWORKs Home Visiting Initiative and California Department of Public Health: California Home Visiting Program (from Children Now).
- Published "Social Media Guidelines" document to help members post/share about the Consortium

- The Consortium Coordinator served on the Maternal Mental Health NOW policy committee.
- Worked with Maternal Mental Health NOW to host the webinars "If Mama Ain't Happy" in English and Spanish
- Became a member of the More LA Smiles Community Linkages Committee (UCLA Dental Transformation Initiative).
- Welcomed four new Consortium member agencies, including:
